Process of paying GP Practice Staff Contributions – April 2015

- From April 2014, all GP practices have paid actual contributions on a monthly basis via the GP1 monthly return form, contributions have then been collected via direct debit on a specified date each month. This process will continue into the 15/16 financial year.
- A new electronic monthly return form (GP1) has been created (see attached). GP Practice managers are required to complete the yellow boxes on the monthly return form (GP1) and populate the members' contribution information into the relevant column based on which scheme the member is currently in. This new form will only be accepted, please disregard all previous versions of this form.
- •As of 1st April 2015 the HSC Pension Service will have 2 schemes running simultaneously together; 1995 Scheme/2008 Scheme and 2015 CARE Scheme. For further information on the new 2015 CARE Scheme please refer to our website.

- Electronic GP1 forms must be completed and **emailed** to hscpensions@hscni.net no later than the 5th day of the following month, please see detail below. A paper copy will not be accepted. There will be **no exceptions.**
- HSC Pension Service will process the direct debit collection on the 14th day of the same month (or the next available banking day). Again, there will be **no exceptions** and the direct debit date is **non-negotiable**. This is vital in order to keep administration to a minimum for both the GP Practices and HSC Pension Service.
- Detailed below are the dates that must be adhered to for the year 2016/17 in order that GP Practices can pay actual payments on a monthly basis and also allow for easier reconciliation of payments by HSC Pension Service.
